General Instructions on How to Submit Your Nomination

Follow these simple steps to ensure that your nomination is well considered:

Nomination Form

Carefully consider the accomplishments of the Latinas in your life and your social network. Identify those whose work deserves recognition. A separate nomination form must be prepared and submitted for each nominee. Each form must be complete and clearly state the reasons for nominating the Latina woman, while emphasizing her accomplishments in her community, profession, and personal life.

NOTE: Only three (3) Latinas will be chosen to be honored.

Nomination deadline

Deadline for submitting nomination forms with supporting documentation is Friday, **February 7, 2020 by 3:00pm**. Eligibility

Any Latina who lives and works in the County of Merced, and who has made a difference in the lives of others in their respective communities within the County of Merced, is eligible for nomination.

Selection Criteria

Nominees will be evaluated for the strength of their accomplishments in three areas: Community service, Professional achievement, and Personal life quality. Each area is considered separately. Professional achievement will not be considered community service as well, for example. Judges decisions are final.
